1. Background

In pursuit of this objective, and to extend quality public services to priority areas across the state in a timely, efficient, and cost-effective manner, Hirshabelle State of Somalia hereby invites eligible, qualified, and experienced suppliers, service providers, and consultancy firms to submit bids for the establishment of Framework Agreements covering the supply of goods, services, and consultancy over the period 2026–2028. This framework focuses on conciliation, federalism, local governance, social contract democratization and political dialogue. These Framework Agreements are intended to streamline procurement processes, ensure value for money, and enable the State to respond more effectively to its evolving operational and developmental needs and will be effective for two years from September 2026 to June 2028.

5. Financial Statements	15%
