### Technical Requirements and Evaluation.

(These legal documents (Tax and Registration) earn no points in the evaluation and the supplier who has not submitted these documents will not appear in the evaluation.)
2. Provide copies of contracts/LPOs as evidence and references from clients for previous similar supplies of vet drugs or related items. (3 certified copies of contracts/LPOs delivered within the last 3 years).
  3. Indicate the Delivery Lead Time. Project Work Plan for full completion.
  4. You must indicate validity period of the tender offer price.

**Further Information to bidders:**

- Currency of offer should be strictly in US Dollars
- ADRA does not undertake to pay by letter of credit (LOC) or in advance of work completion.
- ADRA reserves the right to accept or reject any offer before the award of a contract, or to cancel the bidding process and reject all offers at any time and is not bound to give reasons for its decisions. Canvassing or giving false information will lead to automatic disqualification.
