The endline evaluation will assess the economy and efficiency of delivery, effectiveness, and equity of the intervention in achieving project outcomes and establish the results of the project at outcome and output levels, as well as identifying lessons learnt and potential unintended results.

2- Background

CARE Somalia implements various programs comprising food security and livelihoods, education, water and sanitation, governance and peacebuilding, and health across different regions in Somalia helping the most vulnerable households to cope with the different risks they face and achieve selfreliance. It has identified and selected three impact thematic areas (Climate, water food and nutrition thematic impact area. Humanitarian thematic impact area. and Education & Gender empowerment thematic impact areas) as its core programming focus/strategy and each program has a comprehensive Theory of Change spanning over 10-15 years of the implementation period. 7- Project Implementation Scope Area

This BMZ funded project was implemented in the districts of Afamdow and Badhadhe (Lower Juba), Hobyo (Mu-dug), and Erigavo (Sanaag Somaliland). Drought is projected to intensify significantly in all three regions in 2021, with severe consequences including dried-up water sources, miscarriages among livestock, and dwindling pastureland [8]. The Lower Juba region in southern Somalia has been plagued by instability since the civil war. The social and economic infrastructure is inadequate, and the regional administration is unable to provide basic services.





Since the region is mostly under government control again, it has experienced a steady influx of internally displaced people, mainly from Mogadishu, and returnees from Kenya, putting additional pressure on depleted resources. In Badhadhe district, in southern Lower Juba, fishing, livestock and agriculture are the main sources of income, leaving the population highly vulnerable to climate-induced shocks and climate change. The Mudug region is the most centrally located region in Somalia, with Hobyo being the largest district. The district suffered during the civil war and was without a functioning administration for a long time. Hobyo is regularly plagued by drought and insecurity, including piracy. Due to the level of insecurity, many pastoral households left the region and migrated to cities, which resulted in a loss of livestock. Fishing is the main economic activity in the region and seems to employ mostly youth. Nevertheless, the unemployment rate among youth is high and access to education is low. Sanaag is a region in northern Somalia under the regional administration of Somaliland. Although the political situation appears stable, the region's geographic location between Somaliland and Puntland makes it highly volatile. Almost the entire population of the Erigavo district raises livestock [10]. Social facilities such as schools and hospitals are available, but quality and provision are inadequate.

8- Evaluation Purpose:

The overall purpose of the study is to evaluate the project's impact on the lives of the beneficiaries and its contribution towards the project's main goal: The study aims to assess the project's implementation in terms of its efficiency and effectiveness, while also considering factors such as equity and sustainability in achieving the desired outputs and outcomes. The study will provide an overview of the status of all project indicators compared to baseline findings and offer valuable recommendations for future programming of resilience projects. Key evaluation questions include.

Evaluation Ouestions

The endline evaluation will address the following questions:

- 1. Process Was the project successfully designed and implemented?
- 2. Impact What impact did the project have on the project outcomes? How and why was this impact achieved?
- 3. VfM Did the project demonstrate a good VfM approach?
- 4. Effectiveness What worked (and did not work) to enhance the resilience of chronically vulnerable people and local systems to cope with recurrent shocks and stresses and to adapt to the impacts of climate change and ongoing conflict.
- 5. What impact did the project have on various beneficiary population groups including youths, people living with disabilities, and those from minority groups.
- 6. Sustainability How sustainable were the project activities and was the project successful in leveraging additional interest and investment?



- In what ways did community safety nets and social protection systems help mitigate the use of negative coping mechanisms among the vulnerable populations?
- Evaluate the effectiveness of the training and resources provided to youth and Village Savings and Loan Associations (VSLAs) in diversifying their livelihoods. How have these efforts impacted the community's economic resilience?
- To what degree were the project's outputs achieved as planned? Identify key factors that facilitated the successful implementation of project outputs.
- What were the main obstacles that hindered the achievement of the project outputs? How were these challenges addressed, and what remained unmitigated?
- What are key lessons learned in promoting food and nutrition security?


