- Valid Tax Compliance Certificate.
- Referees (At least three) that you have supplied to include organization name, contact person and a copy LPO or contract of supplies or work done.
- Updated bank statement for the last six months

Where required, all requisite documentation must be scanned in a zip folder. The Zip Folder should contain the name of the company.

Windle reserves the right to accept or reject any applications in whole or in part without giving reasons. Canvassing or giving false information will lead to automatic disqualification.
